### General Information

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants**, such as viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides**, that may come from a variety of sources, such as agriculture, urban stormwater runoff, and residential uses.
- Radioactive contaminants**, that can be naturally occurring or be the result of oil and gas production and mining activities.
- Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and also may come from gas stations, urban storm water runoff, and septic systems.

In order to ensure that tap water is safe to drink, the Colorado Department of Public Health and Environment prescribes regulations limiting the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

### Lead in Drinking Water

If present, elevated levels of lead can cause serious health problems (especially for pregnant women and young children). It is possible that lead levels at your home may be higher than other homes in the community as a result of materials used in your home's plumbing. If you are concerned about lead in your water, you may wish to have your water tested. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. ### Detected Contaminant(s)

Glacier View Meadows Wsa routinely monitors for contaminants in your drinking water according to Federal and State laws. The State of Colorado requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. **Additional Violation Information**

Note: If any violation relates to failing to install adequate filtration or disinfection equipment or processes, or have had a failure of such equipment or processes then the water may be inadequately treated. Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses, and parasites, which can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.

Glacier View Meadows Wsa is required to include an explanation of the violation(s) and the steps taken to resolve the violation(s) with this report.

Glacier View Meadows has taken the following actions on the above violations. These actions address both the Uranium and Gross Alpha violations:

1. Inactivated one of two wells contributing the most to the high Uranium readings in the Lower 8<sup>th</sup> Filing
2. Verified with one test that the remaining well was below the maximum allowed level of Uranium
3. Completed further testing that showed the levels of Uranium are fluctuation in the remaining well. 1<sup>st</sup> Quarter samples were over the MCL.
4. Planned a summer 2012 project to permanently provide water to the Lower 8<sup>th</sup> strictly from the 4<sup>th</sup> Filing water system which is consistently in compliance.
