

CONSOLIDATED GLACIER VIEW MEADOWS ASSOCIATION
RULES AND REGULATIONS
(Section 4 Excerpt from full document)

4. Fishing and Open Spaces / Lake Regulations

a) Access and Identification:

- 1) Lakes and open spaces are exclusive to GVM owners and their guests.
- 2) Trespassers will face legal action by Larimer County Sheriff and Colorado Parks and Wildlife (CPW).
- 3) Guest fishing badges must be visibly worn from the waist up while fishing.
- 4) GVM member fishing badges will have the members photo and must be visible while fishing and have the current year sticker endorsement to be valid. Replacement badges can be issued for a fee.
- 5) No short-term rental (STR) renters or guests may use GVM lakes for fishing, trapping or netting fish or any aquatic species.
- 6) Each lot is allowed a maximum of 2-member fishing passes, issued to individuals named on the property deed filed with Larimer county.
- 7) For properties owned by businesses or trusts, a maximum of 2, listed trustees or owners will be issued fishing badges.
- 8) Property owner fishing badges are not transferable to guests. Guests cannot use a member badge.
- 9) Dependent children of property owners (18 years old and under) will receive an owner's youth pass.
- 10) Failure to comply with badge regulations may result in loss of the badge and penalties for the landowner and guest.

b) Guest Passes:

- 1) Guest passes for ages 16 and up are available at the association building at Gate 8, for daily or multiple-day use. (Prices subject to change and will be listed at GVM office)
- 2) Guest Youth passes (ages 7-15) are sold at a discounted rate. (Prices subject to change and will be listed at GVM office)
- 3) Guest 6 and under are free if accompanied by a GVM member or paying adult guest, any fish kept go towards the member or adult guest pass limit.

c) Fishing Limits:

- 1) Daily limit: 2 rainbow trout per badge or 4 rainbow trout per property lot. Maximum 4 rainbow trout per lot regardless of the number of guest passes purchased.
- 2) Only rainbow trout may be kept at Riddle and Crellin Lakes; all other species must be released immediately. Future changes to species specific bag limits may change and will be listed at GVM office)
- 3) All species must be released immediately at Batterson lake.

d) Fishing Methods and Equipment:

- 1) Batterson Lake: Catch and release only; single-point barbless hooks on fly or lures only; NO treble hooks.
- 2) Absolutely NO bait (live, artificial, scented, or otherwise) allowed at Batterson.
- 3) All lakes require barbless hooks.
- 4) Bait is allowed at Riddle and Crellin
- 5) Only one pole or line per person is allowed.
- 6) We encourage rainbow trout caught on bait to be kept; only 2 fish per badge and a maximum of 4 fish per property per day are allowed, regardless of the number of guest badges.
- 7) The use of bait is not allowed after your limit has been kept for the day.

- 8) The use of live minnows or possession of any fish (dead or alive) classified as a bait fish or fish parts is illegal.
- 9) Chumming or baiting the water is illegal.

e) **General Rules:**

- 1) Remove all trash, food, or debris from GVM areas.
- 2) GVM members are responsible and liable for the actions and conduct of their guests while using GVM lakes, open spaces, trails and facilities. Violation fines of guests are the member responsibility to pay.
- 3) Swimming, camping, overnight parking, or campfires are not permitted on any GVM lake, open space, trail or facilities.
- 4) A CPW fishing license is not required, but a guest pass must accompany kept fish from GVM waters when leaving GVM property per CPW guidelines.
- 5) Please practice good fish handling techniques to minimize fish mortality and keep costs down.
